PROPOSED POULTRY FARM DEVELOPMENT, PURRELDEGGIE FARM, BY CRIEFF

Aviagen Ltd have lodged a proposal of application notice with Perth and Kinross Council for a new poultry farm development at an existing poultry farm; Purreldeggie Farm, by Crieff, PH7 3QP (OS grid reference: NN 8953 2057). Included within this letter are copies of the proposal of application notice, site location plan and public information boards that provide more information on the proposal and public engagement process.

The proposal includes the erection of four sheds and associated works for a pedigree poultry rearing farm. The site will be designed to accommodate 26,000 birds (6,500 per shed) on land that is next to the operational poultry farm. The farm site currently consists of an agricultural field and existing poultry sheds, which will be removed for the construction of the new development.

Relevant supporting studies and environmental assessments will be undertaken as part of the wider planning application process. This planning application will be guided by feedback received during this pre-application consultation period, pre-application feedback received from Perth and Kinross Council (planning reference 21/00429/PREAPP) and the Environmental Impact Assessment screening opinion (planning reference: 21/02073/SCRN).

In order to provide an opportunity for the public to engage, find out more information and discuss the proposals in more detail, a public exhibition is taking place online and via webinars.
